#### Reservations:

All the reservations given below shall be applicable to candidates belonging to Maharashtra State only subject to the fulfillment of the eligibility criteria specified by respective authorities from time to time.

## (a) Reservation for Backward Class category Candidates:

The percentage of seats reserved for candidates of backward class categories belonging to Maharashtra State is as given below. The percentage of reservation is the percentages of the seats available for Maharashtra candidates, coming under the CAP. Socially backward class candidates shall claim the admission under the category to which they belong to, at the time of submission of application form for Centralized Admission Process (C. A. P.) of Admission Regulating Authority, Govt. of Maharashtra.

## (b) Reservation for Persons with Disability Candidate:

Five percent (5%) seats of total seats for Maharashtra candidates per course coming under CAP shall be reserved for Candidates having any of the following minimum 40% benchmark disability.

A single merit list of all eligible candidates shall be prepared. The allotment of seats reserved for the Candidates with Disability shall be done on the basis of an inter-se merit. These seats are available for Maharashtra domiciled candidates in HU / SL seats. The candidates claiming reservation under this category shall submit the certificates from the authority competent for issuing such certificate. The certificate (Pro-forma) should clearly state that the extent of disability is not less than 40% (Forty percent) and the disability is permanent in nature.

#### Note:

i) As per Reservation Policy, the candidates get the allotments of admissions through CAP conducted by Admission Regulation Authority (A. R. A.) Govt. of Maharashtra and accordingly students are admitted to programmes.

ii) The Reservation Policy is made known to the parents, candidates and staff through the

DTE/College brochure.

iii) For candidates getting admissions under institute/management level quota, reservation policy is not applicable and it is as per the rules/regulations of Govt. of Maharashtra.

iv) Economically Weaker Section (EWS) (3%) over and bove seats of sanctioned intake (S.I.) of each of the program.

## (b) Reservation for Persons with Disability Candidate:

Three percent (3%) seats of total sanctioned intake of all the Institutions under CAP shall be reserved for Candidates with Disability.

- (1) 1% seats for Visually impaired (blind) candidates (P1),
- (ii) 1% seats for Speech & hearing impaired (deaf & dumb) candidates (P2),
- (iii) 1% seats for Orthopedic disorders, learning disabilities, Dyslexia, Dyscalculia, Dysgraphica, Spastic (P3)

The allotment of seats reserved for the Candidates with Disability shall be done on the basis of an inter-se merit of respective type of handicap of such candidates. These seats are available in HU / SL seats for Maharashtra domiciled candidates.

The candidates claiming reservation under this category shall submit the certificates strictly as per the Proforma—F/F-1.
